**Instructions:**

- Please note that if you qualify in the Level -1 test, you will be required to appear for the Level -2 test on the same day i.e. February 23, 2023 at the same venue in the afternoon.
- The candidate must bring a print out of the Admit Card enclosed with a recent passport size photograph affixed on it, at the Examination Centre for entry.
- The candidate is also required to bring any one of the listed PHOTO IDENTIFICATION CARD for establishing identity.
- The candidate is required to reach/report examination centre as per date & reporting time mentioned in call letter, late entry i.e. after 9.45 a.m. shall not be allowed.
- Candidates who qualify for the Level 2 Test, will be required to produce all their ORIGINAL CERTIFICATES as mentioned in the advertisement for checking along with one set of self-attested copy of the same on February 23, 2023. Only after verification of the same, candidates will be allowed to appear for Level- 2 test.
- No travelling allowance will be paid if the candidate fails to produce the documents or is rendered in eligible.
- If you are employed in a Government/Semi- Government Organisation / PSU etc. and your application has not been forwarded through proper channel, you will be required to submit a 'No Objection Certificate' from your employer.
